ETC Group launches its first Crypto-ETP on an MSCI index the BX Swiss Exchange

The Swiss stock exchange BX Swiss welcomes ETC Group as a new ETP issuer. ETC Group has listed the ETC Group MSCI Digital Assets Select 20 ETP primarily on BX Swiss. The new Crpto-ETP will now be traded alongside a number of other crypto ETPs on BX Swiss. With the new ETP from ETC Group 67 ETPs from 16 issuers are tradable daily on BX Swiss from 9.00 am to 5.30 pm. The ETP aims to replicate as closely as possible the performance of the MSCI Global Digital Assets Select Top 20 Capped Index, before costs and fees. The index is rebalanced quarterly.
